



## REGISTRATION REQUIREMENTS

The horse must show evidence of being Painted and/or Gaited. The ideal horse possesses a smooth ride with unique markings. The term **Painted** refers to any unusual markings that can be distinguished from the typical solid colored horse, such as markings above the knee or hock, extended facial markings, or exhibiting contrasting colors on the tail or skin. The application must be accompanied by 4 color photos, one of each side, one front, and one back. Good photos are very important since one of the photos will be used on the Registration Certificate. The term **Gaited** refers to a horse that exhibits a gait other than a standard trot. The application must also be accompanied by a short video or signed video waiver form to pass inspection for Gaited along with the appropriate fee.

### **FEES**

A new Registration Certificate will be issued with all the above transactions but must be accompanied with the original Certificate or with the appropriate application submission plus any appropriate fees. These applications become an important part of the records of the Registry. Care should be exercised in giving accurate information and descriptions; however, if any information is unknown please write "unknown".

## **PAINTED GAITED HORSE REGISTRY**

### **APPLICATION FOR REGISTRATION**

It is important that all information be given accurately and completely.

It is also essential that in the blank for sex, you must indicate whether the application is for stallion, mare or gelding.

The application must be accompanied by 4 color photos, one of each side, one front, and one back. Good photos are very important since one of the photos will be used on the Registration Certificate. The application must also be accompanied by a short video to pass inspection for Gaited along with the appropriate fee or sign the video waiver form below.

### **VIDEO WAIVER FORM**

By signing below you are certifying that the horse described on the front of this form is a Gaited horse. This clause may be used when you are **unable** to provide the PGHR with a video for registration purposes or when the horse is already registered in another gaited horse association or has been shown in a gaited horse event.
